



Cocoa Multi-Family Toilet Rebate Program Eligibility Requirements:

1. Rebates are available on a first come first served basis and are available only until the budgeted rebate funds for the **current fiscal year (October 1, 2019—September 29, 2020)** are depleted. The city does not guarantee a rebate if rebate monies have been depleted.
2. Property must have an active City of Cocoa Utilities water account in good standing and the toilet must be installed at a property that receives a water bill from the City of Cocoa.
3. A \$50.00 credit will be applied to the water account for each **1.28 gallon per flush (GPF) toilet or lower installed**. A maximum of two rebates per dwelling unit will be allowed during the lifetime of the program.
4. **Rebate is offered for replacement of an existing 3.5 or more GPF toilets. It does not apply to replacement of a 1.6 GPF or lower toilet. A dual flush toilet does not qualify unless the tank capacity is 1.28 gallons total or lower.**
5. An initial site inspection must be conducted before the current toilets are replaced.
6. Removed toilet cannot be reused and must be disposed of.
7. A post replacement inspection must be performed after toilets have been replaced. Rebates will not be granted to an account before a post replacement inspection occurs.
8. A rebate application must be completed for each toilet replaced. The location address of each toilet must be on the application (unit #, Apt. #, etc.).
9. Replacement ultra low flow toilet must be purchased in the **current fiscal year (October 1, 2019—September 30, 2020)**.
10. It is the customer's responsibility to ensure proper installation. The city of Cocoa does not recommend any brand or manufacture of toilet. You are free to purchase any toilet that meets the **1.28 GPF or lower** standards. Prior to purchase **it is recommended you get estimates for the installation cost**.
11. **Upon receipt and review of the completed rebate form, original receipt, UPC bar code and GPF wording cut from each toilet box for each rebate and attached to the form, if approved, a credit will be applied to the water account that is on the form. Rebates will be returned if they are incomplete.**

In 1992, Federal law (Energy Policy Act of 1992) mandated that all toilets sold in the United States use an average of 1.6 gallons per flush or less. **Therefore most homes built after 1994 won't qualify for a rebate.** By replacing older, high-volume toilets with ultra low-flow (ULF) toilets customers can save a significant amount of water. This reduction in water use translates into cost savings for water consumers.
